- [1207-035] Elaborate Victorian mirror installed in the Metropolitan Restaurant, 29 East Piccadilly Street, Winchester, VA, owned and operated by James H. Pappas, c. 1942-c. 1967. The mirror was presented by the French Art in 1876, during the first centennial of American independence, and

- was the only one of its kind in the United States. The value of the mirror was estimated at \$7000-10,000 dollars in 1950s money, circa 1950s.
- [1207-036] 109 South Stewart Street, Winchester, VA. Aspen Hill, from a painting. Home of Elizabeth and Bushrod Taylor (I). House later demolished for construction of the Winchester Inn, circa 1870.
- [1207-037] Rev. J.R. Graham (1824-1914). Presbyterian minister, friend of Gen. T.J. "Stonewall" Jackson, circa 1895.
- [1207-038] Apple product hauling. Steam tractors pulling wagons loaded with cider barrels. Two white men, two African Americans, one with shovel. No persons identified, circa 1915.
- [1207-039] Apple processing. Apples on conveyor belt, sorter bins, baskets, barrels, etc., circa 1915.
- [1207-040] Oak Grove School, aka Barrett's School, Apple Pie Ridge, Frederick County, VA. Possibly decommissioned and used as a private residence even then. Man and two girls standing outside, circa 1910.
