SCOPE AND CONTENT: This collection contains papers of Robert T. Barton, including journals dating from 1895 to 1916, notebooks, a ledger, legal briefs, and correspondence. Additionally, there are materials from a variety of civic and fraternal organizations of Winchester, Virginia. Some of the material, including newspaper clippings and broadsides, concerns the Readjuster Party of Virginia and the career of Gen. William Mahone.

The collection also includes genealogy material about the Barton family, and papers of Gertrude Barton and Robert T. Barton Jr.

BIOGRAPHICAL/HISTORICAL: Robert Thomas Barton was the son of David W. Barton and Fannie L. Jones and was born in Winchester, VA on Nov. 24, 1842. He served as a captain in the Rockbridge Battery beginning in 1862 until ill health forced him to transfer to the Ordinance Department. In 1865, he was admitted to the bar and became one of the leading lawyers in the state. He was also the author of some standard textbooks, *Barton's Law Practice* and *Barton's Chancery Practice*. Barton was also a member of the Virginia House of Delegates (1884-85), mayor of Winchester in 1896, and sat as chair or president on several state and local organizations. He married twice, first to Katie Knight (1868) and then to Gertrude W. Baker (1890). He had two children with Gertrude. He died on Jan. 17, 1917, and is buried in Mt. Hebron cemetery.

Robert T. Barton Jr. (1891-1980) was born in Winchester, Virginia in 1891 and received his education at the Shenandoah Valley Academy and the University of Virginia, where he studied law. He served as a lieutenant in the Infantry in the Mexican border campaign of 1916 – 1917 and as a captain in the Field Artillery in 1918 – 1919, participating in the battles of St. Mithiel and the Meuse Argonne. In World War II, he saw eighteen months' service overseas with the Army Air Corps as a colonel.

Barton was active in Virginia politics. He served in the Virginia General Assembly in 1926 and on the staffs of three governors of Virginia and was also a former vice president and chairman of the executive committee of the Virginia State Bar Association.
