**SCOPE & CONTENT:** The collection covers the life and times of John Brown, noted abolitionist, and the leader of the raid on the arsenal at Harper's Ferry. While the collection deals mainly with the raid and his trial, it also covers his time in Bloody Kansas.

Centennial and sesquicentennial events are covered, and a life story was published within a month of his death.

**BIBLIOGRAPHICAL/HISTORICAL**: John Brown, was born Torrington, CT in 1800, moved across the country including Ohio, New York, and Pennsylvania. The father of 20 children and an ardent abolitionist, he was accused of murdering pro-slavery settlers in Kansas, known as "Bloody Kansas." In 1859 he led an unsuccessful slave insurrection in Harpers Ferry (then in Virginia). Brown took over the federal arsenal there but was quicky but put down by local militia and Marines led by Robert E. Lee and J.E.B. Stuart. After a 36-hour battle, Brown surrendered. Brought to trial in Charles Town (now West Virginia), he was convicted of conspiracy and treason. He was hanged December 2, 1859
