SCOPE AND CONTENT: The Frederick County, Va., Government Records is a collection of materials documenting the activities of the Frederick County government and its municipalities. Included in this collection are Codes of Law, a bond book for licensing ordinaries, voter registration records, and tax and licensing records. In addition, there are List of Representatives to Frederick County Boards, Commissions, Committees, and Organizations within the collection. Frederick County maintains their own online archives, complete with meeting minutes and other information readily available to the public at www.fcva.us.

BIOGRAPHICAL/HISTORICAL: Prior to European arrival in the Valley, the area that is now Frederick County was inhabited and traversed by Native American tribes. European settlement began in the early 1700s. Frederick County was formed from Orange County, Virginia, in November 1738. Frederick was named for Frederick, then Prince of Wales, and the first court was held in Frederick County in 1743. The county was originally much larger than its present size; including Virginia land in present-day Clarke, Warren, Shenandoah, and Page counties, and West Virginia land in present-day Jefferson, Berkeley, Morgan, Hampshire, and Hardy counties. The county would be the military and political training ground for future president, George Washington. It would be the home of Revolutionary War General Daniel Morgan, who would lead men in the battles of Quebec, Saratoga, and Cowpens. During the Civil War, the county would change hands between Union and Confederate forces more than seventy times and was the site of a number of battles, including Kernstown and Cedar Creek. Notable county residents include author Willa Cather, country singer Patsy Cline, and polar explorer Admiral Richard E. Byrd. Throughout the 20th century, Frederick County became a leading apple grower for the nation. Apples and the apple industry became such a large part of the community that a yearly festival was created in 1924 to celebrate the beginning of the season: the Shenandoah Apple Blossom Festival. The festival continues its celebration every year.
