SCOPE AND CONTENT: The Evan and Edith Harrison Papers Collections contains personal correspondence, including v-mails, between Evan and his wife Edith during his service in World War II. The collection also includes two photographs of Evan Harrison during this period.

BIOGRAPHICAL/HISTORICAL: Evan Harrison was born on July 4, 1921 in Hagerstown, MD to Roy Harrison and Anna Young. During World War II, he served as a corporal in the U.S. Army Air Forces and was awarded the Purple Heart. He passed away on March 4, 2009, and is buried at Mount Hebron Cemetery in Winchester, VA. In his letters, he refers to himself as "Bob." Edith Hardy was born on April 29, 1921 in Frederick County, VA to Val and Gerturde Hardy. Evan and Edith married on April 3, 1942, only a few months before he was shipped off to Camp Lee, VA for training, then to Orlando, FL, and finally to the European theater of war. She died on April 26, 1997, and is buried at Mount Hebron Cemetery in Winchester, VA.
