SCOPE AND CONTENT: This collection is comprised of correspondence, scrapbooks, speeches, notes, recipes, receipts, ledgers, and other papers and artifacts belonging to the estates of Edward Gay Butler and his nephew Richard Cheatham Plater.

The majority of the materials are gardening journals and correspondence on horticultural matters written by Edward Gay Butler while he lived in Clarke County, Virginia. The materials reflect Butler's keen interest in horticulture while he lived at Annefield, near Boyce, from approximately 1900 to 1923, and later Play Gardens, a house located near Millwood. The collection also includes a Bird Diary from Annefield, dated 1914, written by Butler's wife, Emily.

Both Butler and Plater served in the American Red Cross. The collection includes notebooks and a lapel pin from Butler's service during World War I.

BIOGRAPHICAL/HISTORICAL: Richard Cheatham Plater was born on May 9, 1908 in Nashville, Tennessee. On his mother's side he is a descendant of the Custis, Lewis, and Washington families. Plater married Eleanor Leake of Massachusetts and the couple had two sons Ormonde and David. After graduating from Williams College, Massachusetts, Plater worked in various fields before moving to Thibodaux, Louisiana to manage a family run sugar-cane plantation in 1940. Plater took on a number of civic responsibilities including working as a Parish Director for the American Red Cross during World War II.

In 1953, Plater inherited a property known as Play Gardens in Clarke County, Virginia from his uncle, Edward Gay Butler. The Plater family spent an increasing amount of time at Play Gardens and operated a horticulture business. Plater also came to be involved in several local history projects. He guided much of the restoration of the grist mill once owned by the Revolutionary War General Daniel Morgan and was active in the Clarke

County Historical Association. Later in life Plater spent most of his time in Louisiana. He died on Christmas Day, 2004, at his home in Thibodaux at 96 years of age.

Edward Gay Butler is also a descendent of the Lewis and Custis families, as well as the Butler family of Pennsylvania. His great-grandmother was Eleanor Parke Custis (1779-1852), a step-granddaughter of George Washington and Martha Custis Washington, and the wife of Lawrence Lewis (1767-1839). "Nelly" Custis lived at Audley in Clarke County. Her daughter, Frances Parke Lewis (1799-1875), married Edward George Washington Butler (1800-1888). He was a son of Lieutenant Edward Butler, an officer in the Revolutionary War. Butler also became an Army officer, serving in the Mexican-American War (1846-1848). Butler also had several military assignments to Louisiana in the 1820s as the United States expanded its territory to the Southwest. As a result of these assignments Butler decided to purchase land to build a sugar plantation in Iberville Parish, Louisiana.

Edward Gay Butler was born in Iberville Parish, Louisiana on April 18, 1872 to Major Lawrence Lewis Butler, C.S.A. and Mary Susan Butler (née Gay). He was educated at Harvard and later he married Emily Mansfield of St. Louis. In 1900 Edward and his wife visited Clarke County, Virginia. During their stay they decided to purchase Annefield, a plantation house near Boyce. The Butlers resided at Annefield for over two decades before selling it and purchasing Play Gardens. Butler was a horticulturalist and involved with the Garden Club of Virginia. He also served with the American Red Cross during World War I, spending two years in England. Butler died on February 8, 1952, just six months after his wife, Emily, who died on August 26, 1952.

Edward Gay Butler and Richard C. Plater are buried in the Old Chapel Cemetery, Clarke County, VA.
