Miscellaneous Notes—Ben Ritter compiled this alphabetical index of notes from local newspapers from 1896 to 1989, which were taken while looking for other information. The list is primarily of people; 98% are connected in some way with Winchester-Frederick County, Virginia, or the lower (northern) Shenandoah Valley. Both males and females listed were born after 1771 and/or died before 31 December 1982. Most entries are males, most of whom were in a military unit.
