Collection Highlights

New Accessions – First Quarter 2025

Below is a highlight from these new materials capturing a dramatic moment in the history of the Civil War.

Letter, J. D. Starry to George W. Ward, September 21, 1861



Dr. John D. Starry was a surgeon with the 7th Virginia Cavalry during the Civil War. At the time of writing this letter he was stationed in Charlestown, West Virginia.

The letter to George W. Ward (1826-1902) concerns the court-martial of two soldiers implicated in the shooting death of their commanding officer. Ward was, at the time, a judge advocate in the legal proceedings. Starry wrote to urge Ward to ignore calls to turn the case over to civil authorities.

On September 8, 1861, Private James W. Miller of the 7th Virginia Cavalry, shot and killed his commanding officer, a Captain Henderson, following an altercation over the arrest of another soldier. Miller, along with George W. Kerfoot, a fellow soldier accused of inciting Miller to the act, was court-martialed. Miller was found guilty and was executed by firing squad in spring 1862. Kerfoot received a sentence of hard labor.

This was purportedly the first court martial during the war in which a sentence of capital punishment was carried out.



Charlestown Sept 21 1861

Geo W. Ward Esq

Sir

I have received various letters, in regard to the trial by Court Martial, of the prisoners Miller & Kerfoot, to which I have attended as promptly, as possible in my present condition.

The receipt of a letter from Winchester of the 18th inst, containing the following "Mr Ward is anxious (being Judge Advocate) of the Court Martial to know the precise character of your company - if you are under Gen Johnston's command - or whether you are an independent volunteer company & not in regular service. He says Miller has employed a Rockingham Ranger, or Mr Woodson in conjunction with Barton & they intend to make the point that you are not a commissioned officer & that your company is only a volunteer guerrilla company & that a Court Martial is not the proper

Conservator Rachel-Ray Cleveland will be here to discuss how she remedies various types of paper problems such as mold, tears, and tape.

In particular, she will describe the treatment process for a Fairfax Grant between Lord Thomas Fairfax and Henry Baker in 1777, that was recently donated to the Archives. She is also discuss another collection of family papers held by the Archives which is under consideration for conservation treatment.

Rachel-Ray Cleveland, a professional conservator who has served museums, libraries and private collectors along the Eastern Seaboard for the past 25 years. She owns an independent conservation business called Cleveland Conservation of Art on Paper, Inc., located near Laurel, Maryland.
