SCOPE AND CONTENT: The Ann Cary Randolph Jones Family Papers include original letters to William Strother Jones from Alexander Burnet and the correspondence of Ann Cary Jones to family and friends. The letters mainly concern the Civil War, the issue of slavery, and the post-bellum period. The correspondence is transcribed. The Collection also includes land surveys, the Vaucluse farm plat and floor plans, and a codicil to Ann Cary Jones's will.

HISTORICAL/BIOGRAPHICAL: Ann Cary Randolph Jones (1794 – 1877) was the second wife of William Strother Jones Jr. (1783 – 1845). His father was William Strother Jones Sr., a captain in the Continental Army, and subsequently a colonel in the militia. His paternal grandfather was the attorney, legislator, and clerk of court Gabriel Jones (1724-1806). The younger Strother Jones and his wife Ann lived at Vaucluse, the manor house built by his father. They had two sons, Beverley Randolph Jones and Francis Buckner Jones. Ann Cary Randolph Jones is buried in the family cemetery at Vaucluse.

Vaucluse, their family home located near Stephens City, continued to be occupied by their descendants until the Civil War, after which it began to fall into disrepair. It had since been restored and is now a hotel.
